SHRI AMARENDU PRAKASH, DIRECTOR (IN-CHARGE, BOKARO STEEL PLANT), SAIL.

Shri Amarendu Prakash has assumed the post of Director (In-charge, Bokaro Steel Plant)), SAIL w.e.f. 28th September 2020. A B.Tech in Metallurgy from BIT Sindri, (Ranchi University), he is an accomplished technocrat and possesses over 30 years of experience, comprising 24 years in Plant Operations at BSL, 4 years at the Chairman's office in SAIL, and 2 years as a Director on SAIL Board, as In-charge of BSL. Shri Prakash began his career at SAIL in the year 1991 with a posting in Rolling Mills. During their long stint of 20 years in BSL, he mastered the art of steel rolling and finishing.

Shri Prakash, played a crucial role in the timely completion of the upgradation of Hot Strip Mill (HSM) in 1997 and 2007, the implementation of ERP and six sigma certification in the HSM and was the driving force in setting-up the technology hub to serve as a think-tank for research in hot rolling, coordinating patenting and copyright activities.
