**Summary Proceedings of the 53rd Annual General Meeting of Steel
Authority of India Limited (SAIL) held on 16th September, 2025**

The 53rd Annual General Meeting (AGM) of the Members of Steel Authority of India Limited (SAIL) was held at 1030 hours on Tuesday, the 16th September, 2025 through Video Conferencing (VC)/ Other Audio Visual Means (OAVM) in line with the circulars issued by the Ministry of Corporate Affairs/SEBI in this regard.

In terms of Article 62 of the Articles of Association of Steel Authority of India Limited, Shri Amarendu Prakash, Chairman & Managing Director of the Company, chaired the AGM. The meeting was properly convened and constituted and requisite quorum was present throughout the meeting. With the consent of the Chairman & Managing Director and Members present, the Notice of the meeting already circulated to the Members was taken as read. He further stated that all efforts feasible under the circumstances have been made by the Company to enable the Members to participate and vote on the Items being listed in the meeting.

Company Secretary informed the Members that pursuant to Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, the Company had provided remote e-voting facility to its Members which commenced on 12th September, 2025 at 0900 Hours (IST) and ended on 15th September, 2025 at 1700 Hours (IST). The Members who could not exercise their vote through remote e-voting process, were provided the facility to vote during the Annual General Meeting. The Company has engaged the services of M/s. National Securities Depository Limited to provide the e-voting facility to the Members of the Company.

Chairman & Managing Director addressed the Shareholders and outlined the performance of the Company, Safety, New initiatives taken in the Company, Decarbonization Sustainability and Green Steel, Supply of steel in the development of the Nation, Way forward, Corporate

Governance, etc. The Company Secretary read the Statutory Auditors' Report, Report of Comptroller & Auditor General of India on the Financial Statements of the Company for the Financial Year 2024-25 and Secretarial Auditor's Report, and drew attention of the Members to the observations in the Audit Reports and explanations given by the Board of Directors on the observations/qualifications in the Annual Report.

The Company Secretary stated that the Company had issued the Notice dated 22nd August, 2025 containing the following Items for approval of the Members at this AGM and Chairman & Managing Director explained the objectives and implications of the same:

17	Ordinary Resolution: To authorise the Board to carry out the Material Related Party Transactions with Bokaro Power Supply Company Private Limited for an aggregate value of up to Rs.3,000 crore from the date of Annual General Meeting to be held in FY 2025-26 till the Annual General Meeting to be held in FY 2026-27 at arm's length and in ordinary course of business of the Company.
18	Ordinary Resolution: To authorise the Board to carry out the Material Related Party Transactions with Minas De Banga Limitada (Mozambique) for an aggregate value of up to Rs.1,500 crore from the date of Annual General Meeting to be held in FY 2025-26 till the Annual General Meeting to be held in FY 2026-27 at arm's length and in ordinary course of business of the Company.
19	Ordinary Resolution: To ratify the Remuneration of the Cost Auditors of the Company for the Financial Year 2025-26.

Thereafter, the Company Secretary explained the e-voting process for casting votes during the AGM by the Members who have not voted earlier through remote e-voting and otherwise eligible to vote.

The Company Secretary further, mentioned that the Company has appointed Shri Sachin Agarwal, Practising Company Secretary of M/s. Agarwal S. & Associates, as Scrutinizer, to scrutinize the remote e-voting process as well as e-voting during the AGM, in a fair and transparent manner. As it will take time to compile the votes cast, the results of e-voting, both remote E-Voting and E-voting during the AGM, along with the Scrutiniser's Report will be made available on the website of the Company and on the website of M/s.NSDL within the prescribed timeline.

Chairman & Managing Director responded to the observations & questions raised by the Shareholders and thanked the Shareholders for their participation in the meeting.

It is hereby confirmed that the meeting was convened and conducted as per the provisions of the Companies Act, 2013 and Rules thereunder and Secretarial Standards issued by the ICSI.

The meeting concluded at 1234 Hours.
