

RIGHT TO INFORMATION CELL :-Performance **Highlight for 2006-2007**

In order to create a Responsive and Transparent organization, Right to Information Act was implemented in right spirit.

(A). **1265** application were received in SAIL as a whole during 2006-2007 and (177) application were received in SAIL as a whole during October 05 to March 06.

(B). All the application were replied within the stipulated time period.

(C). Out of the total application received during the year 2006-07, **33** cases were referred to CIC and the cases were disposed of by CIC.

2. A workshop to discuss the various provisions of the RTI Act, 2005 and formulate the uniform policy in dealing with the RTI cases was organized at Corporate Office on June 03, 2006. PIOs of SAIL Plants/Units were invited in the workshop. Various of the RTI Act were discussed amongst all PIOs and with the guidance of ED(Law) and ED(Vigilance) a uniform practice was adopted to deal with the RTI requests. The doubts of PIOs were also clarified during the workshop by ED(Law) and ED(Vigilance).

The officer Association of Bhilai Steel Plant in collaboration with NGO's organized a two week information campaign on RTI from 1st July to 15th July 2006 at Bhilai, with the support of the management of Bhilai Steel Plant. The idea behind organizing this workshop was to create awareness amongst masses through mainstream media. Assistance was also provided to those who wished to use RTI but did not have sufficient awareness regarding the same.

(B). All the application were replied within the stipulated time period.

(C). Out of the total application received during the year 2007-08, **30** cases were referred to CIC and the cases were disposed of by CIC.

2. This year in the month of May, 2007 an Awareness programme/workshop on 'Obligation of Public Authorities under RTI' was organized at Corporate Office for the benefit of all PIOs of the SAIL Plants/Units and Senior Officers of Corporate Office. Professor M.M. Ansari, Information Commissioner, CIC and Mr. V.Nayak, Project Coordinator, CHRI took sessions.

The Awareness Programme has already been organized at Bhilai in the month of April, 2007 & at Corporate Office in May 05, 2007. For remaining Plants/Units the programme will be organized & the dates will be finalized in consultation with Plants/Units & CIC.

Implementation of MIS as per directives of CIC and MOS :-

CIC in collaboration with NIC has developed a MIS system for effective monitoring of the implementation of RTI Act, 2005 in Public Authorities. The MIS system has been made mandatory w.e.f. April 01, 2007. A meeting of PIO's and Computer experts of all PSUs under M/o Steel on this was organized by M/o Steel where system engineer from NIC and Dy.Secretary and PIO of M/o Steel informed that as per CIC guidelines this system is being introduced where the data of the cases from the stage of receipt to disposal will have to be entered by the PIOs of all Public Authorities. This system will enable CIC to monitor the implementation of RTI Act online.

MIS system is being implemented by all the PIOs of SAIL wef April 01, 2007.

In order to create a Responsive and Transparent organization, Right to Information Act was implemented in right spirit.

(1). Total receipts for Corporate Office from April 08 To December 08 is 133. Out of the total receipts 56 cases were related to SAIL Plants/Units which have been transferred to the respective Plants/Units u/s 6(3) of RTI Act.

Out of 76 cases all cases have already been disposed off. And remaining 01 cases asked for cost of information .

(B). All the application were replied within the stipulated time period.

(C). Out of the total application received during the above mentioned period, **36** cases were referred to CIC and the cases were disposed of by CIC

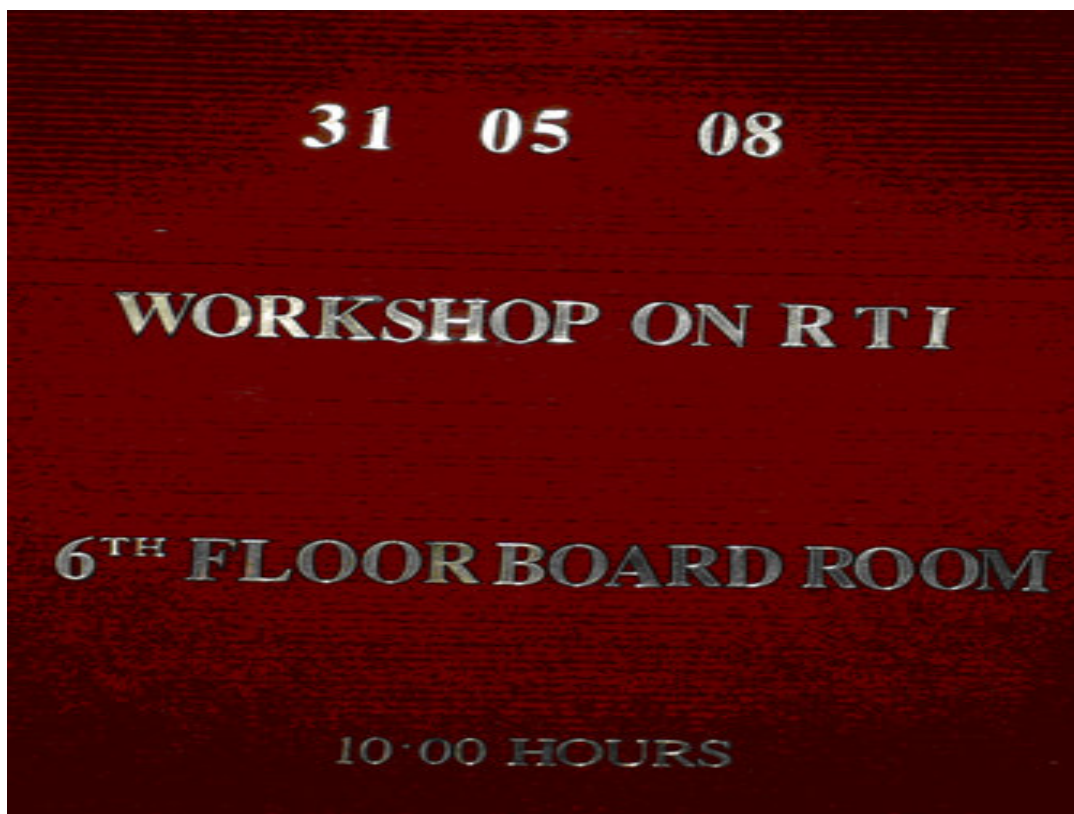
